BI-MONTHLY MEETING MINUTES

1. Welcome/Apologies:

As for the AGM earlier this evening.

- 2. Approval of Minutes of previous meeting, and review of actions PH Minutes of previous meeting proposed by CL; Seconded PH
- 3. Secretary's Report SB / RP

Neither secretary submitted anything to report

4. Treasurer's report - CB

- A meeting was held at Glassel hall regarding Resilience for the hall. We put forward the requirement and effort needed to apply for a wind farm grant. This was very well outlined by Sylvia Stephen. So far, John Wilson of Glassel hall has not responded.
- CB spoke to Kirsty Ryder from Fred Olsen Renewables regarding using some of the potential allocation of funds to be invested in an interest-bearing account.
 She recommended that CB spoke to Fred Olsen Renewables London as Kirsty Leiper has left. Our new contact is Pratik Kerai. Fred Olsen Renewables seems quite positive to this concept.
- CB has researched deposit accounts for business. After a lot of investigation Virgin is the only viable option. We could have an opening account £1.00 instant access account with interest at 3.49%. This would be a relatively simple transaction as we already have three council members who are registered with Virgin Bank. CB suggests an investment of £10,000 providing £343 per year. This will help our accounts as currently the council grant does not cover all our costs. It was agreed that CB should proceed to put this in place.
- CB has contacted the Scottish Fire and Rescue service David Murray, who is the On-Call Commander. He is willing to give a talk regarding wildfire potential in our area. We agreed that this should be a presentation to the wider community. We need to provide a date and venue.
 - Action: CB to suggest either a Tuesday or Thursday. TBC with David Murray

5. Councillor's report

- Police Scotland are looking into speeds through Bridge of Canny
- Many existing 30 mph zones are being reduced to 20mph. This is being funded by Scottish Gov. Maps are available to see where these are.

6. Local Place Plan update – PH

The local place plan is subject to a few minor edits from Aberdeenshire Council and will then be formally adopted and published.

7. IBG Area Resilience – AD

AD was unavailable for this meeting

8. Planning applications and developments – CL

There is nothing substantially new to report, but the Planning Enforcement officer has given Kirkwood Homes until June 20th to lodge their application.

- Revision of some core paths may be needed
- Marr paths group are active, but we cannot join forces with them until we have an active group of our own
- There is on-going discussion regarding the potential path between Inchmarlo Hall / Bothy and Smiddy Park

9. Hill of Fare Windfarm – PH

There was a meeting in Banchory Town Hall on April 24th: the start of a legal process. HOFWIG (Hill of Fare Wind Farm Information Group) is taking the lead, and the next stage will be a Hearing and Inquiry to be held during the first two weeks of September.

There was discussion on whether to make a financial contribution to local pressure group HOFWIG, who are incurring significant legal costs and are taking a lead role in objecting to the development. It was agreed that £300 would be contributed by IBGCC.

PH will be the lead on Socio-Economic impact. Here is his email requesting feedback and comments:

For those that missed the meeting, I undertook as part of the 6 community councils to look at Socio-economics. This is assessed by the developer in Chapter 13 of their application. So what I have put together is a critique of their work, from the "object" standpoint. The work is I hope fairly complete, but it will go through a bit more review by the other community councils and also by HOFWIG and their KC. Ultimately it will be submitted as a written statement to form part of the public enquiry, and will be published on the enquiry website. The deadline for submission is 18th of July.

Could I ask for your feedback on the document by Friday the 20th June please.

We discussed briefly the anxiety caused to some residents regarding the drone that was gathering Lidar information. This is part of a high-resolution survey that is being undertaken by Cairngorm National Park. It will only be used for Lidar data and our privacy is assured.
